同學您好：

本信是提醒您有關 **108 學年度第二學期【學分費】繳費** 重要注意事項，敬請仔細閱讀並於 **繳費截止日前【即 109 年 4 月 24 日前】完成繳費**，謝謝。

1. 若您有選修以下課程，即必須繳交本階段費用：
 - (1) 外語課程之語言實習費；
 - (2) 教育學程學生之教育學分費；
 - (3) 生物技術學程之生物學程費；
 - (4) 學士班延長修業年限學生之學分費或全額學費：
【學分數在 9 學分(含)以下者，繳「學分費」；學分數在 10 學分(含)以上者，改繳**全額**「學費」】；
 - (5) **受疫情影響無法入境之學士班學生**。
 - (6) GMBA、EMBA、EiMBA 學生之學分費。

2. 繳費相關說明：
 - (1) **繳費期間：109 年 4 月 13 日(一)至 109 年 4 月 24 日(五)。**
 - (2) 請於繳費期限內，至 <https://mis.cc.ntu.edu.tw/reg/> 網頁，列印繳費單；繳費前，請再次確認繳費單上的姓名與學號，以免誤繳他人之學費。
 - (3) 請持繳費單至各地郵局、便利超商（便利超商限收金額 6 萬元以下之繳費單）繳交，或以 ATM（ATM 請選「繳費」，不要選「轉帳」，因「繳費」才沒有交易金額上限）、跨行匯款、國內銀行信用卡（網際網路、電話語音、i 繳費 App）、銀聯卡（須卡號為 62 開頭者）方式繳納。
備註 1：到郵局及便利商店繳費，可免繳手續費，請多加利用。

 - (4) 同學亦可至 <https://mis.cc.ntu.edu.tw/reg/> 網頁，點選「銀行服務」→「連線至銀行」，即可連至中國信託學雜費代收平台網頁，透過網路 ATM、網路刷卡或微信支付繳費。
 - (5) **非**各大金融機構之信用卡皆可繳交學雜費，請參考本網址查詢可供繳費之發卡銀行 <https://goo.gl/KVZHth>。
 - (6) 本校無提供從國外匯款方式繳費，國外銀行所發行的信用卡亦無法進行刷卡繳費。

Credit Fees Notification for the 2nd Semester of 2019/2020

Academic Year

Dear student:

This email is to remind you that the credit fees payment period for the second semester of academic year 2019/2020 will be **from Apr. 13 to Apr. 24, 2020**.

1. Who need to pay the credit fees?

Students meeting the following conditions need to pay the credit fees:

- Taking courses of language practicum.
- Taking courses of Teacher's Education program.
- Taking courses of Biotechnology program.
- Undergraduate students extending their study term with nine or fewer credit hours will be charged with credit hour fees; students with ten or more credit hours will be charged with full-amount tuition fees. The billing statements will be generated according to the payment standard for the tuition of their own departments or colleges.
- Undergraduate students who are unable to come to school to attend class due to COVID-19.
- EMBA students who study for the 7th semester.
- GMBA students.
- EiMBA students.

2. How do I print my billing statement and make the payment?

Due date, printing, and payment options:

- **Due Date: Apr. 24, 2020.**
- Please download and print out your billing statement at <https://mis.cc.ntu.edu.tw/reg/>. Before making your payment, please check your name and student number on it to avoid paying other student's credit fees.
- Payment can be made at all post offices or convenience stores (only for the amount less than NTD 60,000 per billing statement at CVS). Payment can also be made via bank ATMs, interbank transfer, or by credit card issued by domestic banks (online banking or telephone banking).
ps. Payments made via post offices and convenience stores are free of charge. Please keep your payment receipt for verification purposes.
- You can visit the website <https://mis.cc.ntu.edu.tw/reg/> and click "Bank

Service” to link to the ChinaTrust Commercial Bank website to make the payment via webATM or by credit cards issued by domestic banks online.

- Just some kinds of credit cards issued by domestic banks can be used to pay the credit fees, you can check it at the website <https://goo.gl/KVZHth>.
- It is NOT accepted to pay the credit fees by international remittance, international wire transfer, international telegraphic transfer, and so on. It is also NOT accepted to pay the credit fees by credit cards ISSUED BY FOREIGN BANKS.

3. What’s the standard of tuition?

4. I have withdrawn from the class. Do I need to pay the credit fee for this class?

According to the “Regulation for class withdrawal,” paid tuition and credit fees of withdrawn courses are non-refundable. Clearing of payments must be done for those who did not complete their payments. Therefore, courses you withdraw are still counted in credit fees and you still need to pay the credit fees.

5. If I don’t pay my credit fees in time, what impacts will there be?

If you do not pay the fee before the deadline, you will not be able to register for next semester according to National Taiwan University's Academic Policies. It is required for graduating students to pay off all required fees before leaving NTU.

6. When the payment status update?

Payment processing may take 1 to 4 business days.

Generally speaking, according to the way that you pay the credit fees:

- Via ATM, interbank transfers, post offices: paying day+1~2 business days
- Via convenience stores: paying day+2~3 business days
- By credit cards: credit card authorization day+3~4 business days
- Please be noted that your payment status will not be changed immediately on the paying day. Your payment status will be revised only after the payment processing aforementioned.
